2025 Summer Employment Position: Resources Information Assistant One full-time, 16-week temporary contract position

Saugeen Valley Conservation Authority (SVCA) invites applications for one Resources Information Assistant position, reporting to SVCA's Administrative Office.

This position is being funded by Canada Summer Jobs. Applicants must be between the ages of 15 and 30 at the beginning of the employment period to be eligible for this position.

Summary of Functions

The Resources Information Assistant will work in the Environmental Planning and Regulations Department of SVCA. This position will primarily include database entry, file management, and GIS applications. Duties may also include assisting staff with site visits. The individual will work closely with Authority planning and regulations staff.

Qualifications

- Possess or working towards a post-secondary degree or diploma in environmental sciences, environmental engineering, natural resources management or a related field
- Ability to work with GIS software products is considered an asset
- Proficiency in Microsoft Office Suite
- Excellent customer service and communication skills
- Sound analytical thinking, planning, and organization skills
- Valid 'G' Class Driver's License

Duties and Responsibilities

- Provide administrative support to the Environmental Planning and Regulations department including record keeping and digitization, database management, and data entry
- Assist in the preparation of relevant background information to support the appropriate department staff
- Support other activities within the Environmental Planning and Regulations department, as required

Work Environment and Conditions

This position is comprised of field and office work. Work performed in the field occurs during all seasons. The outdoor fieldwork will require physical effort (e.g., navigating uneven terrain).
